Nature and approximate age of damage: minor rabbit burrowing; continuing. Very little cairn material remains, the interior being grassed. There are numerous gaps in the kerb, though none is more than 1m across. The largest stones are on the southern side - up to almost 1m high. A few displaced kerb stones lie just outside its perimeter, on the SE side. Scheduling cover appears to be adequate. The monument stands in a field sown with turnips (at the time of inspection), and within a post-and-wire fenced enclosure; the grass is kept down by the occupier who also wages an unsuccessful war against the numerous burrowing rabbits.

An active rabbit burrow on the S side of the monument,between the kerb and the enclosing fence, should be watched. The fence is in good repair. Otherwise, the condition of the monument is unchanged since the first visit two years ago.

Details of the monument are shown on the accompanying sketch - although long grass and weeds made it difficult to verify that all features are extant. Thus it appears that the condition of the site is unchanged since the previous visit three years ago. While control/removal of weeds might be desirable, the site would thereby become very obvious from the nearby busy main road - which would not be appreciated by the occupier. Management requirements: None
