The monument has been abused by being used as a rubbish dump; although the coils rusty wire etc. do not appear to be causing any damage to the cairn, they seriously detract fromits appearance and dignity. Considerable quantities of the cairn material have been dislodged and are now spread around the rim of the cairn. The monument stands on the S side of an irregularly fenced field, grazed intermittently by sheep, and with scattered beech on its N side, and grass and patches of bracken generally. Adequacy of scheduling cover may depend on whether a kerb isburied under the surrounding earth; if such is not the case, the cover appears to be adequate.

The considerable quantity of junk on the cairn could be removed by the Warden, if a skip or similar was provided by the owner/occupier - perhaps two hours work. Its condition is unchanged since the previous visit nearly three years ago. Management requirements: Removal of junk, as above.
