The remains of the chapel take the form of a rough oval of stones, no more than 18" high, 35m north-south and 29m east-west, and as much as 3m wide in places. The area within is undisturbed grassland, with field stones of assorted sizes in numerous small heaps and generally scattered about. There are a couple of apparently dressed stones lying near the two symbol stones, on the southern side of the chapel. The adequacy of scheduling cover depends on whether any of the adjacent land is included and whether this was part of the chapel/burial ground. The field in which the monument stands is used for grazing in autumn and winter and for silage in summer. Cattle habitually wander in and around the chapel area browsing on the nettles and other vegetation there.

SCHEDULED AREA The area is adequate and correctly located. DESCRIPTION The site comprises a large enclosure c. 35m x 29m, with low walls spread to at least 2m. The interior harbours several piles of stones, most probably field clearance. It is difficult to detect any positive evidence of structures within the enclosure. Details are shown on the accompanying sketch. CONDITION OF SITE The field is used in arable-grazing rotation; stock wander at will across the site but do not appear to cause any damage. Weeds are present but are not unusually prolific. The condition of the monument appears to be unchanged since the previous visit. MANAGEMENT REQUIREMENTS None
