# **Non-Technical Summary**

Stuart Farrell was commissioned by Fountains Forestry Ltd in October 2010 to undertake an archaeological desktop and walkover survey for a block of proposed woodland at 81 Melvich, Melvich, Sutherland, Highland.

Work revealed two previously unrecorded archaeological sites to include a structure and remnants of a field boundary, both possibly related to the adjacent Melvich Township.

A number of recommendations have been made in relation to the proposed scheme.



#### 1. Introduction

This report is for an archaeological desktop and walkover survey conducted for Fountains Forestry Ltd for a block of proposed forestry at 81 Melvich, Melvich, Sutherland, Highland.

The fieldwork was conducted on the 4<sup>th</sup> of October 2010.



Figure 2 – Site Location 1:5000. © Fountains Forestry Ltd







Figure 4 – 1<sup>st</sup> Edition ordnance Survey Map of 1876.





Figure 5 – Areas Recommended for Exclusion.

## 3. Objectives

To conduct a desktop and walkover survey to record any archaeological features to the block of proposed forestry. This survey to follow those guidelines as proposed by the Institute of Field Archaeologists (IFA, 1999); and those of the Forestry Commission (FC, 1995).

## 4. Archaeological Survey

# **Desktop & Walkover Results**

A desktop survey was conducted using the following sources:

- Highland Council Historic Environment Record;
- National Monuments Record of Scotland, Edinburgh;
- National Library of Scotland, Edinburgh (Maps);
- Local archives.

Map coverage was limited to the area of interest, as the 1<sup>st</sup> edition OS of 1876 was almost the same as the 2<sup>nd</sup> edition of 1906 and little survey work has been carried out in detail in the 20<sup>th</sup> century, with the next edition being the early 1960's. Early historical maps of the area do not provide enough detail for the area of forestry. Map coverage shows only open ground.

Limited archaeological survey work has previously been conducted to the area of forestry; work by Cathy Dagg (2001) for a new water main noted the buildings to the East of the forestry scheme as part of a desk-based assessment.

Currently no archaeological sites are recorded to the area in Highland Council's Historic Environment Record or the National Monuments Record of Scotland CANMORE or PASTMAP databases.

The following archaeological sites were to be found in or close to the forestry block. Grid references on-site were obtained using a Garmin II GPS using OS data. Sites are as follows:

HER – Highland Council Historic Environment Record NMRS - National Monuments Record of Scotland N/a – not available

Recommendations are given after each site.

1 – Melvich HER – MHG 17818 NMRS – NC86SE 24 Grid Ref: NC 8842/6455 Type – Township

Noted in HER and NMRS of 'A crofting township comprises 83 roofed and 2 unroofed buildings as depicted on the 1<sup>st</sup> edition of the OS 6-inch map (Sutherland 1878, sheet x). 45 roofed and 33 unroofed buildings are shown on the current OS 1:10,560 map (1962). Information from RCAHMS 9 August 1995.'

Walkover reveals the area of proposed forestry is on a steep slope overlooking the township, with at least 3 ruined buildings and walls being visible outside the existing fence line.

No recommendations to be made, as site is outwith boundary of scheme.

2 – Melvich HER – N/a NMRS – N/a Grid Ref: NC 88467/63689 Type – Structure, Possible Cairn



Walkover reveals odd shaped structure situated close to existing gate at 223ft (EPE 15ft) possibly a cairn either reused or partly robbed out. It measures 10m EW by 6.5m NS and visible to the S to a height of 1m rising to a height of about 2m to the centre. Damage to W side possibly by quarrying, also a ramp to W. Eroded on E side by burn/drainage.

Recommend that site be excluded from proposed scheme and 20m wide exclusion area be put in place.

3 – Melvich HER – N/a NMRS – N/a Grid Ref: NC 88246/63321 Type – Field Wall

Walkover reveals corner of field wall at 369ft (EPE 16ft) aligned N-S, to S it runs c20m to track (as shown on OS map) it also runs NE for c25m and is lost in heather. It is 1m wide and up to 0.3m high. It lies adjacent to a path/track which is also shown on OS map. The path/track looks modern.

Recommend that site to be given 20m exclusion area.

The following site is recorded in the vicinity in Highland Council HER and CANMORE but the grid reference may be incorrect.

4 -- Melvich HER -- MHG 9695 NMRS -- NC86SE 15 Grid Ref: NC 88/64

Type - Socketed Bronze Axehead

Noted in HER and NMRS of 'A decorated LBA socketed axe was found on 'the Sutherland - Caithness border' in 1961. (The map sites the find to approximately the Melvich area. (NC 88 64).'

No recommendations to be made, true location unknown.



#### 5. Conclusions

Overall the sites revealed probably relate to a former landscape related to the nearby Melvich Township though they seem to have been abandoned in the early 20<sup>th</sup> century.

Any unexpected archaeological discoveries made during forestry operations should be notified to the Highland Council Archaeology Unit.


