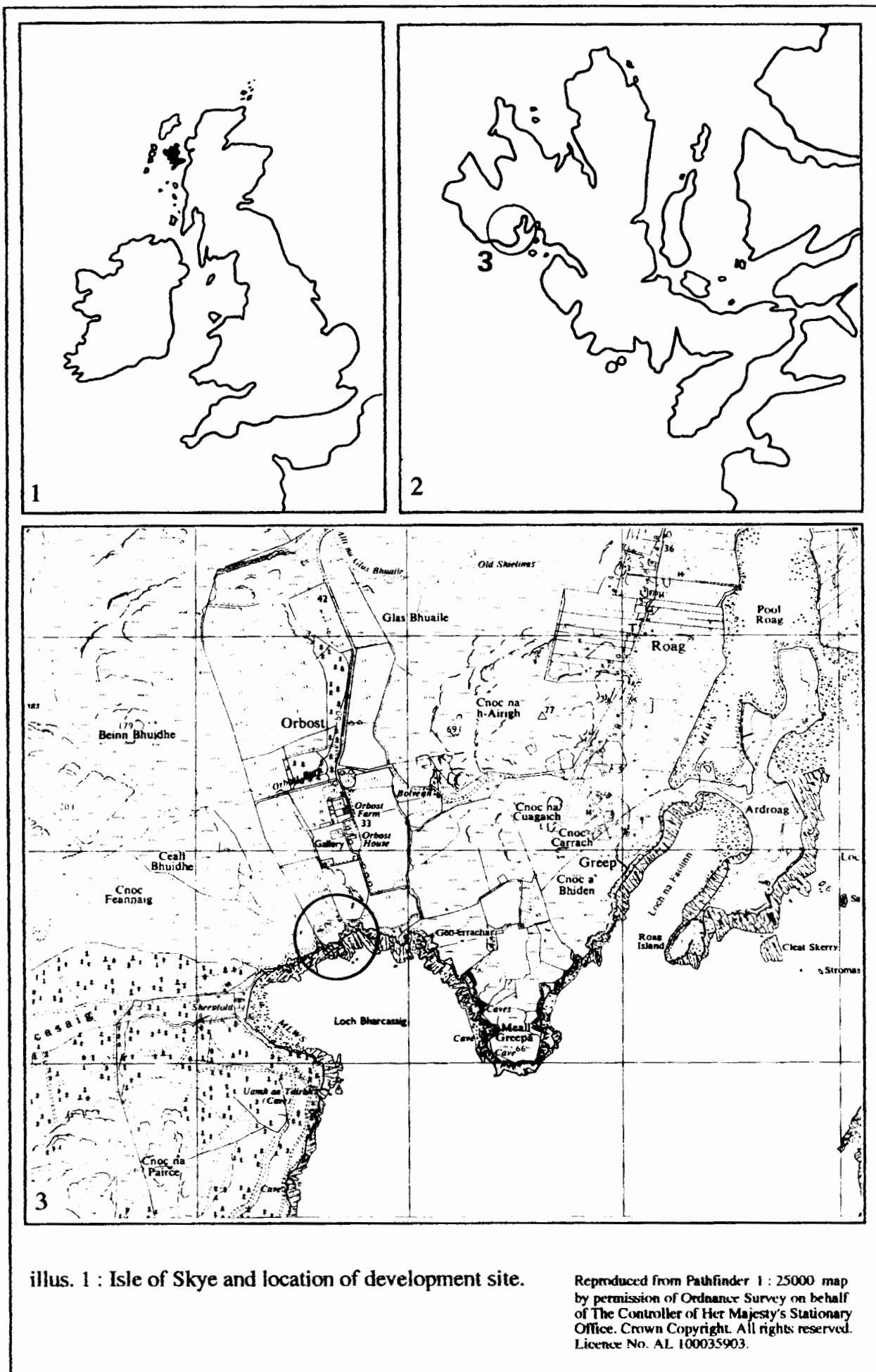

## **HOLDING F, ORBOST.**

Duirinish Parish, Isle of Skye. NG 2568 4265

**Planning Application No. 01/00208/FULSL/SIFR/SCED**

**A watching brief carried out during the excavation of a test trench on the site of a new house at the above OS grid ref. The excavation of the test trench was triggered by the sites close proximity to both a deserted settlement (Biggeary) and to a newly discovered Mesolithic activity site (See Map 2).**

### **1. SUMMARY**

The new house site lies on a sheltered, south-west facing, terrace approximately 30 metres to the north-east of the eastern limit of the now deserted settlement of Biggeary and 90 metres to the north of a recorded Mesolithic lithic scatter. (See Maps 1 and 2)

A minor terraced track leads up to the site from the public road at the rear of Bharcasaig Bay. (See Map 2)

The proximity of the development to the above archaeological sites triggered the inclusion of a test trench and watching brief as an integral part of the planning application.

The site works and watching brief were carried out on the 24<sup>th</sup> of June 2002 during a spell of unseasonably wet and windy weather. The excavation of the trial trench was carried out by a JCB excavator, using a straight edged ditching bucket as required by the Highland Council Archaeology Unit.

### **2. THE SITE WORKS**

#### **2.1 Objectives**

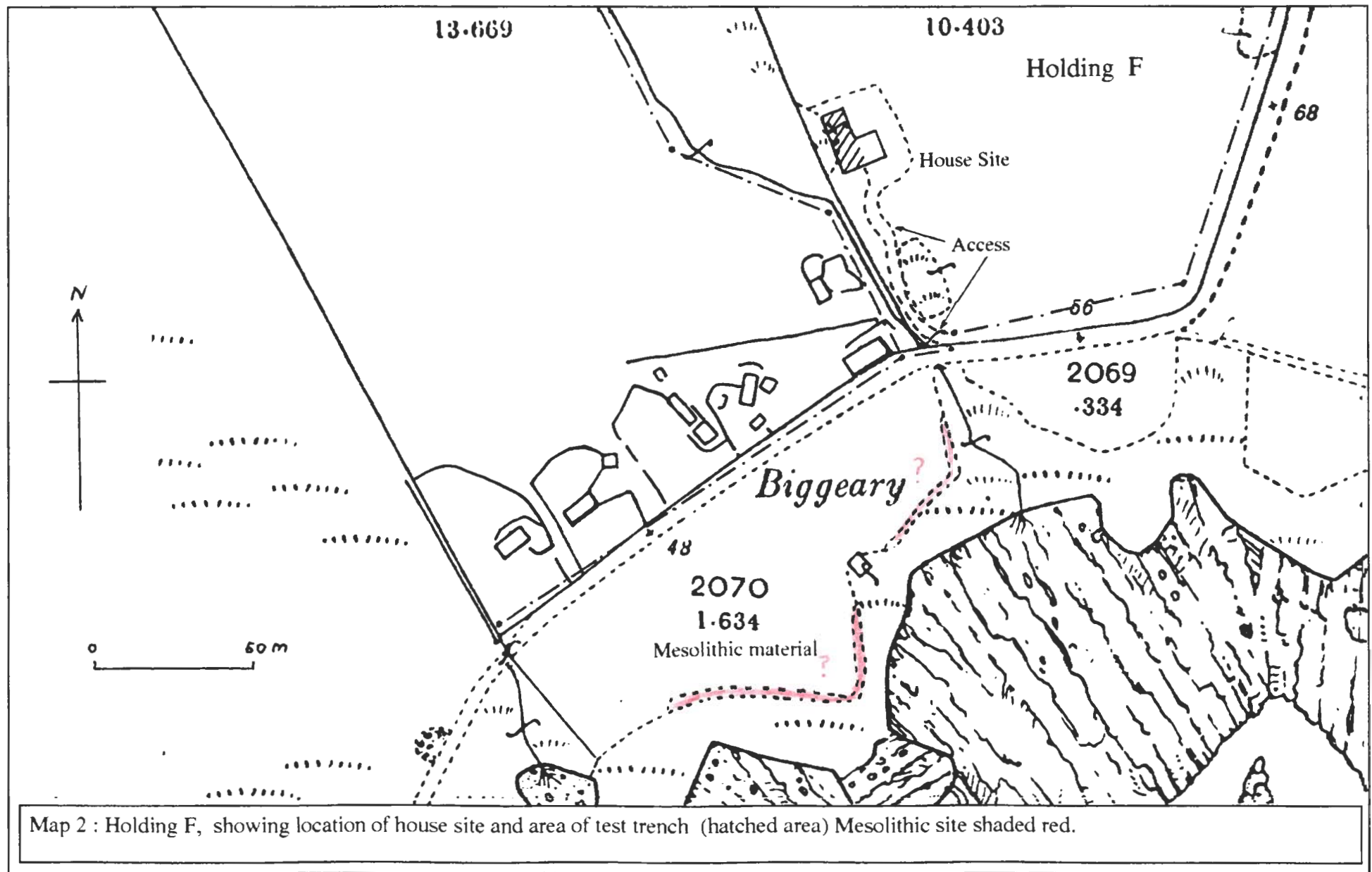
To carry out an archaeological evaluation of the site of a new house prior to the total excavation of the building platform.

Site works consisted of a trial trench (6 metres by 12 metres) which examined the western, level, half of the house platform. The eastern half of the house platform lies on a 45-degree slope, activity on this area would have shown as slope wash in the excavated area.

#### **2.2 Results**

There were no visible signs of buried archaeology on the surface of the site.

Excavation of the trial trench revealed no archaeological features and produced only 3 small body sherds of late 19<sup>th</sup> century pottery (later discarded). There were no lithics present or any other signs of Mesolithic activity.



The presence of a terraced track and pottery fragments may indicate that the platform has seen some agricultural activity within the last 150 years.

The excavated material consisted of from 150mm to 200mm of clean brown loam resting on from 20mm to 150mm of a fine orange sub-soil which lay directly on the uneven surface of the local, somewhat rotten, Basalt rock.

### **3. RECOMMENDATIONS**

The excavation of the trial trench produced no evidence for human activity, other than cultivation in the late 19<sup>th</sup> early 20<sup>th</sup> century.

There are no recommendations regarding this site.
